Grant-in-Aid for Scientific Research (A), Principal Investigator. "An Empirical Analysis on the Mechanism of Generating Social Stratification in the Aged Society with Low Fertility," funded by the Japan Society for the Promotion of Science, 2018-2020 (\$322,000)

This project focused on the dissemination of the findings of the previous project based on the 2015 SSM survey. The major findings of the study appeared in a series of three books published by the University of Tokyo Press in 2021; the English series is expected to be published by Springer. The Japanese book series was divided into three distinct stages in the life course: youth, middle age, and old age. About 40 authors contributed to this series, and Shirahase, who was the chief editor as well as the author of two chapters, organized this book project.

Grant-in-Aid for Specially Promoted Research, Principal Investigator. "A Comprehensive Study of the Structural Change in Social Stratification and the Mechanism of Generating Inequality in the Aging Society with Low Fertility," funded by the Japan Society for the Promotion of Science, 2013-2017 (\$3,321,000).

This is the most prestigious grant awarded by the Japan Society for the Promotion of Science. The main objective of this project was to conduct the seventh survey of social stratification and social mobility in 2015 (2015 SSM survey). SSM surveys have been conducted every 10 years since 1955. An innovative change made in the seventh survey was to expand the respondents' age range from 20 to 69 to 20 to 79, in line with the rapid aging of the population. Over 100 sociologists participated in this project, and the first reports based on the survey are available on the project web page, https://www.l.u-tokyo.ac.jp/2015SSM-PJ/report.html.

Grant-in-Aid for Scientific Research (S), Principal Investigator. "A Comprehensive Study Examining the Forms of Social Stratification in an Aging Society and Constructing Public Norms," funded by the Japan Society for the Promotion of Science, 2008-2012 (\$1,323,000).

This research project was one of the first systematic studies to examine the aging population within the theoretical framework of social stratification in Japan. The study showed that an increasing trend of economic inequality in the society was mainly derived from an increase in the size of the older population, which was characterized by a high degree of inequality. The project discussed what kind of public norms should be constructed for the rapidly aging population in Japan, and what kind of social reform is necessary to make the social security system sustainable.

Health and Labor Science Research Grant, Principal Investigator. "Cross-national Study of Socio-economic Inequalities," funded by the Japanese Ministry of Health, Labor and Welfare, 2004-2006 (\$90,000).

This project is of great significance because the degree and the structure of income inequality calculated using international micro-data among OECD countries (Luxembourg Income Studies) were compared with those based on the Japanese government's micro-data, Comprehensive Survey of People's Living Conditions conducted by the Ministry of Health, Labour, and Welfare. The study found that the degree of income inequality was much higher among the older persons in Japan than in other nations, partly due to the effect of differential family types in which they reside. There was a high degree of inequality in economic well-being between one-person and three-generation families in Japan.

Health and Labor Science Research Grant, Principal Investigator. "The Long-term Care system and the Family in the Aging Society," funded by the Japanese Ministry of Health, Labor and Welfare, 2002-2004 (\$326,000).

The project aimed to examine the impact of a long-term care system that was introduced by the Japanese government in 2000. Socialization of care was one of the main motivations for introducing this new social insurance system in Japan, in light of the large increase in frail older persons that required being taken care of in the family. The situation was aggravated since middle-aged married women, the main care-givers, were more likely to be away at work, than before. In this project, we examined the extent to which the introduction of the long-term care system eased the burden of families in taking care of frail older members, and we concluded that the impact of the long-term care system on lowering the burden of care provided by family members was limited.

Health and Labor Sciences Research Grant, Investigator. "The Generation and Gender Survey," funded by the Japanese Ministry of Health, Labor and Welfare, 2002-2004 (\$400,000).

This is a part of the international research project, the Generations and Gender Programme (GGP), launched by the Population Unit of the United Nations Economic Commission for Europe (UNECE). There was a difficulty in harmonizing the Japanese survey with the core version of GGP, which was designed for European family situations. For instance, respondents were unwilling to answer various kinds of

privacy-related questions, especially those pertaining to partnerships. This project addressed these issues and made comparative study possible.

Health and Labor Science Research Grant, Investigator. "The Impact of Changes in the Family Structure on the Social Security System in Japan," funded by the Japanese Ministry of Health, Labor and Welfare, 2002-2004 (\$170.000).

This project aimed to conduct the first systematic survey on Japanese family and social security systems. Families play a large role in guaranteeing basic livelihood security to its members, and various social systems in Japan, including social security systems heavily depend on the family. Therefore, belonging to a secure family is crucial to protect people's quality of life. However, there is a substantial increase in the number of single-parent families with high poverty, and this change challenges the sustainability of the Japanese social security system.

Health and Labor Science Research Grant, Principal Investigator. "The Assessment of the Extent of Income Inequality in Japan," funded by the Japanese Ministry of Health, Labor and Welfare, 2000-2001 (\$100,000).

The research that Shirahase initiated was well-received by both the academic community and the media because, at that time, economic inequality of Japanese society was being hotly debated. After believing in the myth of Japan's middle-class society for long, it was found that Japan was no longer a very equal society and the degree of economic inequality was at the half-way mark in the rankings of the OECD countries.

Health and Labor Science Research Grant, Investigator. "National Survey of Unmarried People Living with Parents," funded by the National Institute of Population and Social Security Research, 1999-2001 (\$350,000).

The survey of 2000 was the first to focus on unmarried adult children, 18 years old and above, living with their parents. Japan has already suffered from low fertility, which was not high enough to reach the replacement rate, and the increasing phenomenon of delays in leaving their parental homes and remaining unmarried concerned policy makers, academics, and media. Shirahase took the lead in designing the survey to determine how young people behave at home. The results were disseminated and publicized in both academia and media.

Health and Labor Science Research Grant, Principal Investigator. "Comparative Study of Welfare States in Transition," funded by the National Institute of Population and Social Security Research, 1998-2000 (\$100,000).

This project was aimed to follow up on previous research on the state of welfare of Japan, conducted in the mid-1980s, to examine the maintenance of people's livelihood security. Whether Japan was a real welfare state with measures initiated by the government, since the corporate welfare system was well established to guarantee security for their employees and family members, was actively discussed. Our findings

are that Japan is a type of ad-hoc welfare state, and its social expenses are still limited when compared to Europe.

Health and Labor Science Research Grant, Investigator. "National Survey of Family in Japan," funded by the National Institute of Population and Social Security Research, 1997-1999 (\$200,000).

The main aim of this project was to conduct the third National Survey of Family in Japan, which was the first large-scale nationally representative survey on families. This survey was particularly important to see how couples share household chores and childbearing, and it was one of the earliest surveys to examine the relationship between adult children and parents regardless of whether they co-reside or not.
