## Consultation with Members

## 1. VISION, MISSION, PRINCIPLES AND VALUES

- Slight expansion of mission (adding: 'promote and assist in science diplomacy' and 'assist ... in the face of the evolution of science systems') and principles (adding 'reflexivity and adaptability')
- Paragraphs on freedom and responsibility in science are being redrafted by the Committee for Freedom and Responsibility in Science


## 2. GENERAL ASSEMBLY

- From three- to four-year intervals
- Establishment of most advisory bodies and committees delegated to Governing Board


## 3. ADVISORY BODIES

- Only two statutory standing committees:
- Committee for Freedom and Responsibility in Science
- Committee for Finance, Audit and Risk
- Others established as needed by Governing Board, covering at a minimum:
- Science planning and programmes
- Fundraising
- Four-year, staggered mandates

## GOVERNING BOARD AND OFFICERS

- Four-year, staggered mandates
- Options for the transition into a staggered system will be proposed for a vote of the General Assembly
- President-elect appointed midway between ordinary sessions of General

Assembly

- Officers will function as an Executive Committee


## ELECTIONS

- Nominations and Elections Committee (NEC) formed from nominations from Members, outgoing Governing Board members, Fellowship Council member, independent chair
- Membership of Elections Committee approved by vote of General Assembly
- Four-year mandate
- Elections held every two years
- Officers selected by NEC from nominations, approved individually by a $2 / 3$ vote of the General Assembly
- Ordinary members of Governing Board elected by a vote of the General Assembly from shortlist proposed by Governing Board
- Question: How to manage co-option of additional Board member for diversity?

## FINANCES

- Introducing possibility to provide partial financial support to Officers' institutions, within limits of French law and with annual approval of amounts by Members.
- Charitable trust introduced.

## ISSUES RELATED TO MEMBERSHIP, VOTING AND DUES

a. Gaps in membership - need to be more inclusive and attractive - vital for legitimacy as the global voice for science
b. Complex inherited voting systems - needs simplification
c. Two parallel inherited dues structures (for former ICSU and ISSC members)

- needs rationalization and recalibration


## MEMBERSHIP CATEGORIES PROPOSAL

- Category 1: International disciplinary bodies
- Category 2: National members
- Category 3: Relevant scientific bodies that do not fall under Cat. 1 or 2, but which should have a vote and nominating rights and pay dues
- Category 4: Observers (foundations, private sector organizations, ...)


## VOTING PROPOSAL

- Voting on financial matters: weighted according to dues
- Voting on scientific matters: one member, one vote
- Voting on elections and constitutional matters - weighted:
- Category 1: 40\%
- Category 2: 40\% (and one vote per country)
- Category 3: 20\%
- Category 4: no vote


## SPECIAL CASES OF POTENTIAL OVERLAPPING/MULTIPLE MEMBERSHIP

- In the case of an application for membership in Category 1 or 2 where the membership might overlap or compete with existing members, the support of the relevant existing member would have to be sought.
