
Conditions & Requirements for Visa-Free Entry

- 1 Passport valid for at least six months from the date of entry is essential for visa-free travel to The Sultanate of Oman.
- The visitor must hold a return ticket, hotel reservation, health insurance, and to cover the expenses during the stay.
- The visitor will be allowed to stay in the Sultanate of Oman for a period of 14 days, which cannot be extended or transferred
- The husband and children benefit from this facility, even if they are not nationals of the above countries, as long as they are accompanied by the visitor after submitting the required documents
- Foreigners residing in the Gulf Cooperation Council countries, as well as foreigners who have work visas according to specific professions or tourist visas, can benefit from this facility if they are nationals of the countries.
- For nationals of the 2nd list to obtain this facility, they must be residents of one of the Gulf Cooperation Council countries according to the specified professions or have a valid entry visa for one of the following countries (the United States, Canada, Australia, the United Kingdom, the Schengen Agreement countries and Japan)
- After the expiry of the granted period, late fines will be calculated at 10 riyals per day, and implementing the legal procedures.
- This type of facility does not allow the person to carry out any work within the Sultanate, nor does it allow to apply to any type of visa that followed by residency.







